

## Joker Tattoo Video Contest Rules

Contest is open to all people age 18 or older.

**To enter:** Log on to [www.JokerTattoo.net](http://www.JokerTattoo.net) and visit the Tattoo Contest page. Upload your video using the video upload button at the bottom of the Video Contest Page.

Enter as often as you wish; however, each entry must meet the requirements below and must be submitted separately. Entrants are required to agree to these Official Rules at the time of entry. By clicking the "Upload Video" button at the bottom of the Video Contest Page, the contestant is accepting these Official Rules.

After all votes are counted, Joker Tattoo will declare a winner. This decision is final.

Entry must meet all of the following requirements or it will be disqualified.

- You must abide by these requirements. Joker Tattoo reserves the right to prescreen, monitor and remove postings, all at its discretion.
- Entry must not violate third-party rights including, but not limited to: copyrights, trademark, and right of publicity. Do not show any third-party trademarks, company names or logos.
- Entry must be original, unpublished, and the sole property of the submitter.

- To submit your video, you must read and agree to these official rules ("Official Rules") by clicking the "Upload Video" button. You agree that by uploading this video, you relinquish all rights, as outlined herein, and the video, its characters and content becomes the property of Joker Tattoo.

**Judging:** A panel of judges will select the top 25 finalists which will then be posted to the Joker Tattoo Video Contest Page. After the finalists videos are posted, public voting will be enabled. The voters IP address will restrict each computer to one vote. Once the public votes are counted, Joker Tattoo will determine a winner.
